

MINUTES

BOARD OF FIRE COMMISSIONERS

DECEMBER 19, 2007

A regular meeting of the Board of Fire Commissioners was called to order at 6:00 PM by Chairman Pasquale Nuzzolillo. Also present were Commissioners Peter Criscuolo, Sam Muzio, Michael Zuccarelli, Daniel Fleming, Chief Vincent Landisio and Deputy Chief Frank Gersz.

Chairman Nuzzolillo turned the meeting over to Chief Landisio recognizing the fire personnel and American Medical Response personnel for their heart save on November 22, 2007. Chief read a short presentation and then the resident whose life was saved was introduced and participated in giving out the awards. The gentleman then gave a short speech thanking all.

Chairman Nuzzolillo then turned the meeting over to First Selectman Janet McCarty for the organizational meeting. First Selectman McCarty entertained a nomination for Chairman of the Board of Fire Commissioners. Commissioner Muzio nominated Chairman Nuzzolillo for reappointment to Chairman. Commissioner Zuccarelli seconded. First Selectman McCarty then asked if there were any more nominations for Chairman. Commissioner Fleming then nominated Commissioner Criscuolo. Commissioner Criscuolo seconded. Voted for Chairman Nuzzolillo: Nuzzolillo-yes, Muzio-yes, Zuccarelli-yes, Voted for Commissioner Criscuolo: Criscuolo-yes, Fleming-yes
First Selectman McCarty announced Chairman Nuzzolillo is elected Chairman.

First Selectman McCarty then entertained a nomination for Vice Chairman of the Board of Fire Commissioners. Commissioner Zuccarelli nominated Commissioner Muzio for Vice Chairman. Chairman Nuzzolillo seconded. Voted: Nuzzolillo-yes, Muzio-yes, Zuccarelli-yes, Criscuolo-abstained, Fleming-did not vote

First Selectman McCarty announced Commissioner Muzio is elected Vice Chairman.

First Selectman McCarty then entertained a nomination for Secretary of the Board of Fire Commissioners. Chairman Nuzzolillo nominated Commissioner Criscuolo for Secretary. Commissioner Muzio seconded. Voted: Nuzzolillo-yes, Muzio-yes, Zuccarelli-yes, Criscuolo-yes, Fleming-yes

First Selectman McCarty congratulated all the members and thanked all the firefighters for their dedication and hard work. Chairman Nuzzolillo thanked First Selectman McCarty for running the organizational meeting.

Commissioner Criscuolo then asked to make some comments before beginning the meeting of the Board of Fire Commissioners. He had discussion in reference to becoming Chairman of the Fire Commission. Chairman Nuzzolillo then responded to his comments. Chairman then asked that the discussion be ended and that the agenda for the Board of Fire Commission be discussed.

Chairman Nuzzolillo then attempted to proceed with the agenda of the meeting. Commissioner Criscuolo felt there was still more discussion in reference to the position of Chairman. Chairman Nuzzolillo asked that a motion be made to adjourn if the meeting could not continue. Commissioner Muzio moved for adjournment at 6:30 PM. Commissioner Zuccarelli seconded.
