

MINUTES

BOARD OF FIRE COMMISSION

MAY 27, 2015

A regular meeting of the Board of Fire Commission was called to order at 6:00 PM by Chairman Pat Nuzzolillo. Also present were Commissioners Michael Zuccarelli, Peter Criscuolo, Joseph Cappucci, Chief Vincent Landisio and Deputy Chief David Marcarelli. Commissioner William Mitchell was absent from the meeting.

Chief Landisio spoke of a call received on April 5, 2015 for childbirth emergency on I-91. He then invited the family up to award the stork pins to Firefighters Ron Prisco, Michael Pomichter and Richard Filosi.

Chairman Nuzzolillo on behalf of the Board of Fire Commission thanked all involved on the birth of a healthy child.

Commissioner Criscuolo made a motion to accept the minutes of the meeting held on April 22, 2015. Commissioner Cappucci seconded.
