The commission moved to the second floor classroom for the purpose of swearing in Anthony Santagata as a police officer.

Anthony Santagata was sworn in as a police officer by Chairman D'Errico at 8:12pm.

First Selectman Freda addressed the audience and congratulated Officer Santagata.

Chairman D’Errico asked for a motion to adjourn. Commissioner Lazaroff made the motion, second by Commissioner Monz. The motion passed unanimously. The time was 8:14pm.
